7. New Business

- Special meeting with the Burleigh County Highway Department on 9-12-2023.
 - Budget is in a short fall, County is moving \$ from savings to cover costs.
 - Inflation, Equipment breakdowns and getting parts are a huge issue.
 - Getting new / replacement blades is almost impossible. Some have been on order for over a year, they also are waiting for chips, hoses, and other parts so the blades will be usable.
 - 22-23 snow cost was \$3.3 mil, annual average for snow operations is \$845 K. (\$3.3 is all roads County and Township, dozing, surplus fuel ect.)
 - 1. County hardships
 - a. Manpower shortages, normally hire 15 summer help, 5 with CDL and 10 without CDL. BCHD only had 5 total hired for 2023, none with CDLs.
 - b. Blading and snow plowing routes. Currently each operator covers 170 to 190 miles, hoping to drop to 120 miles per operator.
 - c. BCHD is hoping to hire temp operators over the winter to help out with snow operations and other maintenance.
 - There will be no increase of Township contracts.
 - BCHD went from 4 mil in the budget to 5 mil, NDCC allows up to 10 mil. Other County Highway Departments are at 10 mil and have been for a long time.
 - 66th St RR overpass is on hold, 2018 estimate was \$9.4 mil, and 2023 estimate is over \$26.8 mil.
 - 1. BNSF is willing to cover part of the overpass cost.
- NDTOA 57th Convention
 - December 4th and 5th at the Ramada Inn, Bismarck
- 7550 Star Lane in Country Ridge 2nd Subdivision.
 - There are 2 large potholes that need to be fixed.
 - Quality Asphalt or the Burleigh County Highway will do the road repairs.
- Intersection of Runnel road and shoal Drive.
 - 4 way stop suggested due to semi-blind intersections and near miss occurrences.
 - a. Motion by Gerald and 2nd by Curt to put a 4 way stop in place.
- 57th Ave NE which connects to 66th St NE.
 - Per Burleigh County Highway Department, this road will be taken over by the County.
